**FINANCIAL** Renters must sign an agreement assuming responsibility for the equipment as well as personal responsibility. A deposit of 20% of the rental fee is required to confirm reservation. We will refund 80% of deposit if notice of cancellation is received in writing more than 2 weeks prior, and 50% if more than 1 week prior. No refund will be provided if notice of cancellation is received less than one week prior to rental period. Payment must be received in full prior to the commencement of the rental period. Any damaged or lost equipment will be charged to the renter at the full replacement cost, including shipping. A late return penalty will be charged at the daily rate. A \$20 boat washing fee may be assessed, as necessary. Those renting equipment for use on whitewater must have prior training and experience. Daily and evening rentals must be returned by 11 pm on the day they are rented. A *Visa or MasterCard* credit card imprint is required prior to the boats and equipment being released to the renter. We do not accept American Express.

**EQUIPMENT PICK-UP** Unless otherwise specified, the equipment can be picked up at 4702 Anderson Thomson Blvd. (Peace River Flats area, north of the Racquet Club on Back Bay). To reach our location from uptown: Proceed down Franklin (50<sup>th</sup>) Ave. north, toward Old Town. Turn left past Fritz Thiel Ball Park (opposite Hak's Auto Body) on to Hamilton Dr. Turn right on to Lois Lane (just past prominent A-Frame). Turn left on to Anderson-Thomson Blvd. Go to the last house on the left. Please take only the items assigned to you in your rental agreement.

**EQUIPMENT CARE** Renters agree to take proper care of all equipment in order to eliminate damage and reduce wear and tear. This care includes but is not limited to the following:

**Boats:** Boats are to be carried (never dragged) over all portages, emptied and carried up onto shore at all stops. Boats are not to be tied up and left in the water where subsurface rocks will erode hull. When transporting boats it is the responsibility of the

renter to ensure they are securely tied to vehicles. Do not leave boats tied on top of vehicles for extended periods; the sun will cause them to distort.

**Paddles:** Not to be used for digging, prying or bouncing off rocks.

**PFDS & Spray Decks:** To be used only for the purpose intended. (Not to be used for kneelers, seat cushions, etc.) Keep away from campfires and gasoline/camp fuel. Dry and store away from direct sunlight.

**Throw Ropes:** To be used for rescue or practice only. Not to be used for securing boats, as clotheslines, etc.

**EQUIPMENT RETURN** All boats are to be returned to the storage yard with all accessory equipment placed underneath. Do not put any equipment away, as it will need to be inspected and inventoried first. A \$20 cleaning fee will be assessed if equipment is returned in a soiled condition.

**SAFETY** Familiarize yourself and become comfortable with your boat. Develop your paddling skills including braces, rolls (kayak) and rescues. Take a paddling course from a qualified instructor in advance of your rental period. Bring safety and first aid equipment on every trip. Install bow and stern lines. Wear clothing appropriate for the weather and water conditions, and anticipate change of weather. Leave a written travel plan with someone, tell them when you plan to return and what to do if you do not return by the specified time. (I.e. call local Search and Rescue services.) Become familiar with the area you are planning to paddle. For example, talk to local residents. Get a weather forecast for each day you plan to be out. (Locally, call 873-2734). A common danger to paddlers is hypothermia. Learn about signs, symptoms, prevention and treatment. A personal flotation device (lifejacket) **MUST BE WORN AT ALL TIMES** when on the water. Never paddle farther from shore than you care to swim back! When paddling on Back Bay or Yellowknife Bay, stay along the shore to avoid floatplane traffic. Any young person under the age of 16 must be accompanied by an adult who accepts full responsibility for the young person's safety. No motors or mechanical devices may be used to propel or tow the equipment assigned to you. The equipment herein described is leased for general recreation purposes only.

**WAIVER.** I,  acknowledge that this is an agreement for hire only, and not a sale, conditional or otherwise, and that the equipment shall remain the absolute property of NARWAL. I agree that I have no authority to loan, pledge or sublet the equipment, that I will not so loan, pledge or sublet the same.

. I accept said equipment in its present condition. I further understand that NARWAL makes no warranty as to the fitness or suitability of the equipment. I will return the above noted equipment to NARWAL in the same condition as when received by me (reasonable wear and tear only excepted) or otherwise agree to pay NARWAL the full amount, as assessed by NARWAL for any lost, damaged or dirty equipment.

. I agree to return the equipment to the NARWAL equipment storage area NOT later than the time due back. Time is of the essence of this agreement and I agree, if the equipment is returned later than the time due, to pay NARWAL an increased rental fee as assessed by NARWAL, including a late fee assessed at the daily rate.

. I authorize any assessed amount for lost, damaged, dirty or late equipment to be charged to my credit card unless alternative arrangements are made, at the discretion of NARWAL.

. I understand and acknowledge that canoeing, kayaking, camping or other outdoor activities can be dangerous and that certain bodily injury or death can arise as a consequence of the use, transport or storage of this equipment. I hereby assume all risks, both for myself and any others in connection with the use of the equipment and its intended purposes, and in consideration for NARWAL leasing to me the aforesaid equipment, I hereby release and forever discharge NARWAL, its directors, officers, shareholders, employees, agents and assignees of and from any and all actions, causes of action, contracts, claims and demands for damages, loss, or injury, suits, debts, sums of money, indemnity, expenses, interest, costs and claims of any and every kind and nature whatsoever, at law or in equity, which I ever had, now have, or can hereafter have by reason of or existing out of any causes whatsoever existing up to and inclusive of the date of this release.

. I further state that I am of lawful age (19 years old) and legally competent to sign this affirmation and release; that I have read and fully understand and accept the terms and conditions of this contract; and I have signed this contract under my own free will. (A person between the ages between the ages of 16 and 18 years may enter into this lease on the condition that this contract is also signed by their parent(s) or guardians(s) who have read, understand and accept the above stated terms and conditions, and accept full responsibility for the young person's safety, actions, and inactions. No person under the age of 16 years may enter into this lease.)

. I understand that I am fully responsible for all costs associated with transporting all rental equipment to and from the NARWAL equipment storage area unless authorized in writing by a NARWAL agent.

. This lease contains the entire agreement between the parties and I acknowledge that it has not relied on any other warranties or representations express or implied, oral or in writing. This lease shall be governed by and construed in accordance with the laws of the Northwest Territories.

My signature below acknowledges that I have read, understand and accept all additional rental conditions and information outlined on both sides of this form, including information on deposits, equipment care, return arrangements and safety.
